



- That the Shree Swami Vivekanand Shikshan Sanstha is of Non-Proprietary Character.
- 3) That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
- 4) That no part of income from the Institution is being and will be diverted to any individual in the Trust. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
- 5) That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
- That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination by laws and the circulars issued by the Board from time to time. The school under takes to abide by the provisions contained in the affiliation & examination by laws, directions issued from time to time and the law of the land.
 - 8) That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
 - 9) That the school will ensure that the Building Safety, Fire- Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
 - 10) That the school will ensure that all required infrastructure is available with the school before starting classes.
 - 11) That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
 - 12) That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
